

**OFFICIAL MINUTES  
REGULAR MEETING  
PRINGLE-MORSE CONSOLIDATED INDEPENDENT SCHOOL DISTRICT  
BOARD of TRUSTEES  
APRIL 17, 2025**

Trustees Present: Jerry Crowl, Wirt Davis, Christy Hart, James Lieb, John Lieb, and Jason Varnon.

Trustees Absent: Rily Urban

Administration Present: Superintendent Scott Burrow and Business Manager Laurie Green.

Guest present: Greg Huseman with Huseman Builders, and Terry Stegall with King's Cleaners.

A quorum was established, and President James Lieb called the meeting to order at 7:09 p.m.

Greg Huseman, with Huseman Builders, presented Quotes for Gym renovations.

Terry Stegall with King's Cleaners talked to trustees about the services King's Cleaners would be able to provide.

No one was present for Public Comments/Audience Participation.

John Lieb moved to approve the consent agenda, which included the board meeting minutes on March 27, 2025. Wirt Davis seconded the motion, which carried 6-0.

Business Manager Laurie Green presented the financial reports, including budget reports, and cash position.

There were no student transfers.

No action was taken regarding the proposed gym renovation by Huseman Builders.

Jason Varnon moved to approve the contract with King's for custodial services. Wirt Davis seconded the motion, which carried 6-0.

Wirt Davis moved to increase the stipend for teachers working with the Strong Foundation Grant. Jerry Crowl seconded the motion, and it carried 6-0.

Jason Varnon motioned to approve a budget amendment for the LASO Cycle 3 Grant. Wirt seconded the motion, and it carried 6-0.

John Lieb moved to approve the Hansford County Tax Assessor's contract to assess and collect taxes for Pringle-Morse Consolidated Independent School District. Jerry Crowl seconded the motion, which carried 6-0.

Trustees reviewed the Hutchinson County Appraisal District's financial audit report.

Jerry Crowl motioned to engage Bown, Graham and Company P.C. as the district's financial auditor. John Lieb seconded the motion, and it carried 6-0.

The Board of Trustees convened in closed session at 8:56 p.m. on April 17, 2025, in accordance with the Texas Open Meetings Act and ended its closed session at 9:32 p.m. on April 17, 2025. Jason Varnon moved to approve hiring Natalie Hinojosa as a teacher and girls' coach. Wirt Davis seconded the motion, and it carried 6-0.

The Trustees set May 22, 2025, at 7:00 p.m. as the next board meeting.

Superintendent Burrow submitted Principal Hicks's Student activity report. (See Attachment.)

Burrow reported that:  
Enrollment is at 121.

He will move forward with the auditorium seating at Gruver and advised trustees on his plans for transporting the seats from Gruver to storage until the auditorium floor is ready to install them. He is also planning for Elizabeth and others to do some needed painting around the campus.

There were no teacher resignations.

The meeting adjourned at 9:43 p.m.
