

**OFFICIAL MINUTES  
REGULAR MEETING  
PRINGLE-MORSE CONSOLIDATED INDEPENDENT SCHOOL DISTRICT  
BOARD of TRUSTEES  
MAY 22, 2025**

Trustees Present: Wirt Davis, Christy Hart, James Lieb, John Lieb, Rily Urban, and Jason Varnon.

Trustees Absent: Jerry Crowl.

Administration Present: Superintendent Scott Burrow, Principal Jordan Hicks, and Business Manager Laurie Green.

A quorum was established, and President James Lieb called the meeting to order at 7:06 p.m.

No one was present for public comments or audience participation.

John Lieb moved to approve the consent agenda, which included the minutes of the board meeting held on April 17, 2025. Jason Varnon seconded the motion, which carried 6-0.

Business Manager Laurie Green presented the financial reports, including budget reports, and cash position.

The Board of Trustees convened in closed session at 7:11 p.m. on May 22, 2025, in accordance with the Texas Open Meetings Act and ended its closed session at 7:25 p.m. on May 22, 2025. Rily Urban moved to approve returning and new student transfers. Jason Varnon seconded the motion, and it carried 6-0. (See Attachments).

Wirt Davis motioned to approve the renewal of the student accident insurance for the 2025-2026 school year. John Lieb seconded the motion, and it carried 6-0.

Rily Urban motioned to approve the Wellness Policy as recommended by the SHAC Committee. Wirt Davis seconded the motion, and it carried 6-0.

Wirt Davis moved to approve the bid from Amarillo Custom Coatings to clean, repair holes, seal, and apply a clear coat to the auditorium floors after asbestos abatement. Rily Urban seconded the motion, and it carried 6-0.

Rily Urban motioned to have the gym floors refinished, have Huseman Builders add new lights and mats, and paint the gym, with the understanding that the stands will maintain the wood finish look. Wirt Davis seconded the motion, and it carried 6-0.

On matters related to school safety, Superintendent Burrow reported that the new roof access door in the gym has been replaced, and the window tint has been completed.

No action was taken on new personnel hires.

John Lieb moved to approve the resignation of Brandea Allen. Rily Urban seconded the motion, and it carried 6-0.

The Trustees set May 19, 2025, at 7:00 p.m. as the next board meeting.

Principal Hicks submitted the student activity report. (See attached.)

Superintendent Burrow reported:

Enrollment is at 121.

Minor repairs are lined up for the summer, and the front-end repair on one of the buses has been completed. He also reported on the gym renovations and auditorium project. Burrow informed the trustees of his plans to hire an aide and reported on legislative updates.

The meeting adjourned at 9:30 p.m.
